STURGIS

The Sturgis family was researched and compiled by Vernon L. Skinner, Jr. Initial information comes from Floyd L. Otter, Origins of the Sturgis Family in Virginia & Maryland, Ash Tree Echo, Jan. 1979, Vol. XIV, Issue 1, p. 38-43. This was augmented and updated with input from Gerald Collins, Frank Courtney, Kay Davis, Linda Harrison, and Judy Stell, as well as published abstracts (many within the last 10 years) of various records of Maryland, Delaware, and Virginia: probate, deeds, tax lists, patriot information, etc. While the main objective was to resolve certain specific lines, many of the other lines had to be constructed in order to properly place certain persons. The effort is based on factual data obtained from the various sources. However, quite often logic, associated with the rules of probate in Maryland, was applied to determine some of the relationships. In some cases, negative or inverse logic was applied, i.e., a particular person can not fit in one particular line, therefore they must fit in another line. (The best example is the wives of the various John Sturgises in the early 1800s.)

(Sinah Sturgis to John Foster, p. 103, Delilah Sturgis deed to John Foster, p. 95, Martha Sturgis to Isaiah Sturgis p. 3, Mary Sturgis to Wm. Foster, p. 346; between Mary Sturges, spinster one of the daughters and coheirs of Jonathan Sturges decceased...Jonathan died intestate leaving Bridget, Delilah, Sinah, Agnes, Mary & Elizabeth to divide 110 acres...10/30/17(64)) Accomack, VA. Clement Parker is the guardian of Agnes, Mary, and Elisabeth Sturgis in 1763. Land was purchased from John Scarborough & his wife Mary Cade Wise of MD in 1747. He may be the Jonathon Sturgis of Kent Co. DE. He married Parker (N) and had children: Bridget, Delilah, Sinah, Agnes, Mary, Elisabeth

3. John Sturgis of Accomack Co. VA. He bought "Coxes' Choice" in 1753 Worcester Co. as John Sturgis. He bought "Hungary Quarter" in 1753 as John Sturgis of Accomack. In 1768, he deeded some or all of "Hungary Quarter" to Alexander Thomas Russell. Paid tax on land from 1756 to 1771. He had two sons: Joshua Sturgis paid tax on "New Holland," "Hungary Quarter" and "Coxes Chance/Choice" in 1783 1M, 3F, Wicomico Hundred. Joshua d. 1802 leaving a will. He had land in Somerset & Worcester. He was surety to William Sturgis in 1783. Next of Kin in 1803 were William Sturgis and Salley Sturgis. His children: Salley, of age in 1803, Daughter b. before 1783, by 2nd wife Esther d. 1806, he had a son, Joshua Sturgis; William Sturgis probably died 1814 with wife, Sally.

4. Daniel Sturgis, blacksmith, no land, Wicomico Hundred, Worcester Co. 1783 MD Tax List

5. Jonathon Sturgis, wife Hannah (N), had a son, Lemuel Sturgis b. Nov. 5, 1809, died at age 93. (Bible Records of DE, Vol VII)

1. John¹ Sturgis (Sr.) birth date unknown. John died 1684 in Accomack Co., VA. He married twice. He married **Dorothy Savage** in Nicholas Co., VA, September 1, 1661. Dorothy was the daughter of Thomas Savage (carpenter) and Rebecca(wife of Thomas Savage). A Dorothy Savage married John Sturgis in 1661-2 and this Dorothy was the sister of Rebecca, widow of John Tompson and wife of Richard Robinson. Richard Robinson, in his 1695 will, named John Sturgis as son of his wife's sister, and he named Sarah Savage, daughter of Thomas and Bridget Savage and called her "god daughter." Although it would appear that Sarah Savage was his niece. Whitelaw writes that "whether or not there were other children of Thomas and Rebecca Savage is unknown, but they did have a son Thomas to inherit the land." (Virginia's Eastern Shore, N106, p. 512) These relationships would indicate that Dorothy and Rebecca, sisters, were daughters of Thomas Savage "carpenter" and sisters of Thomas Savage, Jr. and John Savage.

In 1662, William and Sarah Smith sold 100 acres of N107 to John Tilney; he and his wife Ann (Smith) assigned to John Sterges, and he and his wife Dorothy reassigned to Mary Parramore. In 1671, she (Mary Parramore) sold back to William Smith and three years later the sale was confirmed by John Parramore. (Ralph T. Whitelaw, Virginia's Eastern Shore, p. 514)

He married **Elizabeth Bundick** about 1667. Elizabeth was the daughter of Richard Bundick and Ruth(wife of Richard Bundick). Will dated March 6, 1683, probate August 5, 1684 Accomack, named wife Elizabeth, son John, son Richard (-21), son Jonathan (-20), son Daniel (-16), daughter Dorothy Nevill, daughter Ann Sturgis. witnesses: Richard Bundick and David Jones. (Stratton Nottingham, Wills & Administrations of Accomack Co., VA, p. 13)

3. John² Sturgis (Jr.) (John¹) was born about 1663. John died after 1739 in MD.

He married twice. He married **Priscilla Hill** after August 14, 1688. Priscilla was the daughter of Robert Hill (Sr.) and Jane (wife of Robert Hill). Priscilla died before 1731. Robert Hill named his daughter, Presilla, in his will. Jane Hill, widow of Robert, gave her daughter Persilla a feather bed and furniture to be delivered at her day of marriage, dated August 14, 1688.

He married **Elisabeth (N)** before July 19, 1731. Elisabeth died before 1739. On July 19, 1731, John Sturgis and his wife Elisabeth deeded to Johnson Hill "Robinson's Inheritance," land that was willed to John Sturgis in 1695. She probably died prior to 1739 as she is not mentioned in the 1739 deed. John deposed his age as 19 in 1682. Richard Robinson of Northampton County, VA left 300 acres of "Robinsons Inheritance" to his wife's sister's son, John Sturgis, in 1695. "Robinsons Inheritance" was in Somerset County, MD on Bouquetenorten Bay. Dorothy Savage's sister, Rebecca, had married Richard Robinson. Rebecca and Richard Robinson evidently were close to or raised John after his mother's death and his father's remarriage to Elizabeth Bundick. (Floyd Otter, Origins of the Sturgis Family in VA, Ash Tree Echo, Jan. 1979, Vol XIV, Issue 1, pp. 38-43) In 1735, John Sturgis, Sr. & Johnson Hill resurveyed "Robinson's Inheritance." In 1739, John deeded "Robinson's Inheritance" to his youngest son, Daniel. John is not found on the Somerset Tax Lists 1733-1735.

5. Jonathon² Sturgis (John¹) birth date unknown. Jonathon died 1721 in Kent Co., DE.

He married Elisabeth Stockley before 1702. Elisabeth was the daughter of John Stockley. She married Richard Hill before 1729. Elisabeth died before October 12, 1745. He witnessed a will in Accomack County, VA in 1696. He is probably the Jonathon Sturgis who married Elisabeth by 1704 in Sussex County. He is probably the Jonathon Sturgis who was cited as constable in Annamessex Hundred, Somerset Co., MD in 1709, and married a daughter of John Stockley (d. 1715) by 1715. Jonathon is not present on the 1724 Tax List for Somerset County and there are no other references in Sussex County records.

Jonathon Sturgis and Elisabeth Stockley had the following children:

She married William Dixon before 1699. William died 1710 in Somerset Co., MD. He called Elizabeth Bundick Sturgis his mother-in-law in his will.

7. **Daniel² Sturgis** (John¹) was born after 1668. Daniel died 1723 in Accomack Co., VA.

He married Elisabeth (N). Daniel's mother gave him 200 acres of land in 1706, the 200 acres had been gifted to her and her husband, John Sturgis, by her parents in 1667. In 1721, Daniel deeded the south half to his nephew, Richard Sturgis. Daniel's son, William, succeeded him to the land at A118 in Accomack County. (Ralph T. Whitelaw, Virginia's Eastern Shore, p. 1134) Daniel died intestate.

Daniel Sturgis and Elisabeth (N) had the following children:

11, 1755 to Baily Scott and secured by Moses Griffeth. (James H. Marshall, Wills & Administrations of Northampton Co., VA, p. 363)

8. **Richard² Sturgis** (John¹) was born 1672. Richard died 1696 in Accomack Co., VA. He married **Sarah Wharton**. Sarah was the daughter of Francis Wharton. Sarah was named Sarah Sturgis in her father's will of 1695 and called wife of Richard Sturgis. Richard left a will dated February 12, 1695, probate September 15, 1696. He named wife Sarah and children John (-16), Richard (-16) and Elizabeth (-16). Witnesses: Thomas Crippen, George Parker, Sr. and Thomas Jones. (Stratton Nottingham, Wills & Administrations of Accomack Co., VA, p. 27)

Richard Sturgis and Sarah Wharton had the following children:

20. Stockley³ Sturgis (Jonathon², John¹) was born before 1718. Stockley died 1787 in Kent Co., DE. He married three times. He married **Mary Stout** before May 31, 1746. Mary died before 1752. He married **Phebe** (N) before 1759. He married **Sarah Levick** before 1765. Stockley was is shown on the 1755 Tax List at Little Creek Hundred and living at Little Creek Hundred in 1782. He was styled "gentleman" in 1765. He left a will.

9. **Richard³ Sturgis (I)** (John², John¹) birth date unknown. Richard died 1743 in Worcester Co., MD. He married **Elinor (N)**. Elinor died after 1743. Elinor patented 100 acres "Widows Lott" in 1741. On November 15, 1761 as widow of Richard Sturgis, she sold 50 acres to Thomas Sturgis. On May 10, 1794, Richard Sturgis (Jr) sold to Samuel Adams Harper 3 acres of "Widows Lott" and "Harpers Discovery." In 1760, it was resurveyed to "Chance" by Thomas Sturgis. (Ruth T. Dryden, Worcester Land Records, p. 671) (further research: Elinor may have been a Walton or Jones) Richard is shown in 1724 Tax List of Somerset County as head of household. He lived at Mattapony Hundred. He patented Hog Quarter, 100 acres, in 1742.

Richard may have been married twice. It is not clear that his daughter, who married (N) Johnson, or his son, John, were children by wife, Elinor. Elinor deeded land to some of Richard's sons, but had no interaction with John.

Will dated April 3, 1743, probate May 3, 1743. Shown as a planter, 100 acres of land surveyed by the name of Hog Quarter last April that the patent shall come out in my son John Sturgis name. Wife plantation, bed & furniture, Yoke of steers, mare called Fenix; son Richard plantation after wife's death; daughter Tabitha trundle bed & furniture; daughter Nelly high bedstead; son Thomas bed & furniture that is upstairs & new gun; son John gun that was my father's, steer called Bobb and cow called Mottley, bee hive; son William, brass gun; son Stephen, gun that formerly was called John's; grandchild when she is sixteen, a heifer; son Joshua; executors were wife and son John; witnesses: Alexander Buncle, John Sturgis, Jonathan Sturgis. (Liber JW2 transcribed by Suzanne B. Hurley, Ocean City Lifesaving Museum; Worcester Co. MD Wills 1742-1759 JW2, f.7, Neil & Leslie Keddie, Family Tree Bookshop)

10. Joshua³ Sturgis (Capt.) (John², John¹) birth date unknown. Joshua died 1774 in Worcester Co., MD. He married twice. He married Sarah Bevans about 1729. Sarah was the daughter of Rowland Beavans and Mary Berry. She married William Laws in Somerset Co., MD, before 1729. He married Mary (Purnell) before 1770. She married Isaac Houston after 1774. Mary died after 1787. Mary and Joshua sold "Hog Quarter" to John Jones in 1770. In 1787, Mary Houston, widow of Joshua Sturgis, and her husband, Isaac Houston, sold her rights to "Wickedness Neck" to William Davis. (Ruth T. Dryden, Worcester Land Records) It is thought her surname is Purnell because of the name given their daughter. Joshua was in his father's household in 1724 and cited in his father's will. He is named next-of-kin to Micajah Sturgis in 1763. In his 1749 will, John Bevans calls Joshua Sturgis his "brother." It would appear that this is the Joshua whose will was dated March 12, 1773 and probated April 15, 1774. He named his daughter, Martha, and "cousins" Joshua Sturgis of Richard, Jacob Sturgis of William and Abraham Outten Sturgis of Jonathan. (a nephew and two great nephews).

In 1739, he bought 300 acres "Wickenoughs Neck" from George Parker. He gave 100 acres to son-in-law Elijah Laws in 1741. In 1787, Mary Houston, widow of Joshua Sturgis, and her husband Isaac Houston, sold her rights to "Wickedness Neck" to William Davis. George Parker's will dated 1767 Worcester gives part of "Wickeness" to his son, John; one of the witnesses to that will was a Joshua Sturgis, Jr., along with Elijah Laws.

On the 1739 tax list for Bogerternorton Hundred of Somerset County, Elijah Laws was in the household of Joshua Sturgis, who was next to Rev. Thos Fletcher, who was rector of All Hallows Parish at that time. On 16 June 1741 Joshua Sturgis, Gent. for love and affection to my loving son...Elijah Laws, land Wicksnough (Wickenough, Wickeness) later in the deed it mentions my "Son in Law" [step-son?], Elijah Laws (MF:227).

A Joshua Sturgis patented "Hog Quarter" in Worcester. In 1770 Joshua and Mary Sturgis sold to John Jones and in 1776 he sold to Elijah Laws, who willed to his son, James Laws. (Ruth T. Dryden, Worcester Land Records) Joshua left 500 acres "Wickedness Neck," 95 acres "Sturgis Addition to Timothy's Point," "Common Garden," "Castlegreen" and a house in Snow Hill to his daughter, Martha.

Estate Inventories 1774-1777, Vern Skinner: Joshua Sturgis 6/5/1776, appraisers: William Lane & Peter Chaille; creditors: Outten Stugis & Philip Quinton; next of kin: Stephen Sturgis & John Sturgis; executrix: Mary, wife of Isaac Hempston (Houston).

Joshua Sturgis (Capt.) had the following children:

i. ?Joshua⁴ Sturgis (Jr.). ?Joshua died before 1774. A Joshua Sturgis, Jr. is shown as witness to the will of George Parker in 1767, when Parker leaves "Wickeness" to his son, John. Elijah and Elijah Laws, Jr. are also witnesses to this will. That this Joshua may be the son of Captain Joshua is only suggested by his being called "Jr." and his proximity to the property "Wickedness" and Elijah Laws.

It might be that Captain Joshua Sturgis had a son, Joshua, Jr., who predeceased him. Captain Sturgis does not name a son nor has information been found suggesting that Captain Joshua even had a son. This may be Joshua d. 1792, son of John Sturgis III.

ii. Daughter Sturgis. Daughter died before 1774. She married Elijah Laws before 1741. Elijah was born about 1723. Elijah was the son of William Laws. He married Comfort Sturgis before 1778. Elijah died 1778 in Worcester Co., MD. On the 1739 tax list for Bogerternorton Hundred of Somerset County, Elijah Laws was in the household of Joshua Sturgis, who was next to Rev. Thos Fletcher, who was rector of All Hallows Parish at that time. On 16 June 1741 Joshua Sturgis, Gent. for love and affection to my loving son...Elijah Laws, land Wicksnough (Wickenough, Wickeness)

later in the deed it mentions my "Son in Law" [step-son?], Elijah Laws (MF:227).

Elijah is given 100 acres of "Wickedness Neck" as "son-in-law" by Joshua Sturgis in 1741. He purchased "Hog Quarter" in 1776 from John Jones. (Ruth T. Dryden, Worcester Land Records) His will was dated October 17, 1813, probated January 4, 1814. He named sons John, Elijah, James and Joshua and daughter, Patty. He left his son, James 146 acres in the forest of "Addition to Hog Quarter." Witnesses were William Townsend, Peter Townsend and Peter Evans. (Ruth T. Dryden, Worcester Will Book MH, f.27)

Joshua Sturgis (Capt.) and Mary (Purnell) had the following child:

48 iii. Martha Purnell Sturgis was born before 1773. Martha's father left her 500 acres "Wickedness Neck," 95 acres "Sturgis Addition to Timothy's Point," "Common Garden," and "Castlegreen," and a house in Snow Hill.

11. William³ Sturgis (John², John¹) birth date unknown.

He married **Elizabeth** (N). He was in his father's household in 1724. He is not cited on 1727 Tax List. Inventory in 1727.

William Sturgis and Elizabeth(wife of William Sturgis) had the following children:

13. John³ Sturgis (III) (John², John¹) was born about 1693. John died 1758 in Worcester Co., MD. He married twice. He married **Mary Carroll** before 1714. Mary was born 1687. Mary was the daughter of Thomas Carroll (Jr.) and Rebecca Fisher. Mary died before 1728. He married **Elinor (Johnson)** after 1728. Elinor may have been the daughter of George Johnson d. 1732 Accomack. Afradozie Johnson is a surety to John Sturgis on the estate of Littleton in 1743. John is shown with his own household in 1730; Somerset Tax Lists; Mattapony Hundred. In 1714, John Sturges, Jr. and his wife Mary sell land. In 1734, Donnock Dennis deeded to John Sturgis, Jr. "Rochester." From 1735-1740 living in Boquertornorton Hundred, per Tax Lists. He died after 1743 when he administered the estate of his son, Littleton. Probably the John who died in 1758, Boquerternorton Hundred.

Will dated August 25, 1755, probated November 8, 1758. He named wife Eliner and left her dwelling plantation and estate. Wife and son Joshua Sturgis executors; witnesses: Joshua Sturgis, Henry Turner and John Teague. (Worcester Co. MD Wills JW2, f.191, Neil & Leslie Keddie, Family Tree Bookshop)

John Sturgis (III) and Elinor (Johnson) had the following children:

- iii. William (aka Micajah) Sturgis was born 1728. William died 1762 in Worcester Co., MD. He married Mary Bishop after 1757. Mary was born 1729. He died intestate and his estate was probated by his brother, Daniel.

John Sturgis (III) and Mary Carroll had the following child:

55 v. Littleton Sturgis was born about 1718. Littleton died 1743 in Worcester Co., MD. Littleton died intestate and his father administered his estate.

14. **Jonathan³ Sturgis** (John², John¹) was born about 1708. Jonathan died 1756 in Somerset Co., MD. He married **Esther Outten** about 1730. Esther was born about 1708. Esther was the daughter of John Outten (Sr.) and Mary Gray. Esther died after 1755. John Outten said in his will that his wife was pregnant and this is probably that child. She was named in her mother's will. Jonathan is shown in his father's household in 1724 Pocomoke Hundred. Esther's brother, Abraham, deeded them land in 1733. Jonathan was named next-of-kin to Esther's brother, Abraham Outten, in 1747. In 1753, with his wife Esther, he sold land to John Sturgis of Accomack, VA. Next of kin

are shown as Joshua Sturgis and Rachel Davis.

Jonathan Sturgis and Esther Outten had the following children:

- 56 i. Elijah⁴ Sturgis. Elijah died 1758 in Worcester Co., MD.
- ii. ?Abraham Sturgis. ?Abraham died before 1788. An Abraham Sturgis was witness to the will of a Mary Purnell in 1772; he was witness to a will in 1778. He is not on the 1783 tax list. An Abraham Sturgis served as Private, Worcester Militia, Wicomico Battalion, Capt. Fisher Walton's Company, 5th Class, July 15, 1780. Took the Oath of Allegiance in Worcester in 1778 before the Honorable John Selby. And an Abraham Sturgis rendered patriotic service by collecting cattle for the use of the military on September 25, 1781. (Henry C. 15. **Daniel³ Sturgis** (John², John¹) was born about 1708. Daniel died 1749 in Worcester Co., MD. He married twice. He married **Mary Outten** about 1730. Mary was the daughter of John Outten (Jr.) and Sarah 'Sary' Purnell. She was called Mary Sturgis in her father's 1733 will.

He married **Priscilla (N)** after 1730. Daniel had his own household in 1733. He received land from his father in 1739. He left part of tract "Robinsons Inheritance" to his sons, John Outten Sturgis and Shadrack Sturgis, in 1749. (Ruth T. Dryden, Worcester Land Records) John's will was written as he was dying from "being shott with a ball" on November 11, 1749, probate December 5, 1749. The Maryland Gazette reported "Sturges, Daniel, was shot dead by a person unknown some weeks ago at Matapony Hundred, Worcester County." (Floyd L. Otter, Origins of the Sturgis Family in Virginia and Maryland, Ash Tree Echo, April, 1979, Vol. XIV #2, p. 75-80)

His will gave son John Outten 250A "Inheritance"; wife, Negro man Essix; son Shadrack, dwelling plantation and water mill; son Daniel, Negro Sepie; daughter Elizabeth, Negro Sothey after wife's death; wife, chest, bed & furniture; executor was brother Joshua Sturgis; witness: Joachim White, William Beachboard and Daniel Selby. Widow Priscilla elected to take her thirds. (Worcester Co. MD Wills JW2, f.59, Neil & Leslie Keddie, Family Tree Bookshop)

Daniel Sturgis and Priscilla (N) had the following children:

- i. Shadrack⁴ Sturgis. Shadrack died 1796 in DE. He married Comfort (N). Shadrack and wife Comfort sold 450 acres of "Robinsons Inheritance" to Parker Selby of Parker in 1763. (Ruth T. Dryden, Worcester Land Records) He may be the Shadrack Sturgis who was shown on the 1782 Delaware tax list.
- 63 ii. Daniel Sturgis. He is no doubt the Daniel Sturgis of Daniel who paid tax on 100 acres "Partnership" in 1768 and 1769. He is cited as Capt. Daniel Sturgis in 1774. In 1773, Daniel Sturgis of Accomack Co. VA sold 100 acres "Partnership" to William Andrews (Worcester deeds). In 1788, Daniel Sturgis witnessed the will of William Elliott in Accomack Co., VA.

27. William³ Sturgis (Daniel², John¹) birth date unknown. William died 1751 in Accomack Co., VA. He married **Martha (N)**. William inherited land from his father at A118, which he left to Martha and then to son William. (Ralph T. Whitelaw, Virginia's Eastern Shore, p. 1134) His will was dated January 7, 1745/6, probated January 29, 1750/51. He named wife Martha and sons William and Joshua, Isaiah, Jacob and daughters Martha, Elizabeth, Bathsheba and Mary Coverly. He said that the balance of the estate was to be divided between the rest of my children. (Stratton Nottingham, Wills & Administrations of Accomack Co., VA, p. 159)

William Sturgis and Martha (N) had the following children:

Adah died after 1766. She released her dower rights to the land at N83 in 1766 when her son, William, sold it. (Ralph T. Whitelaw, Virginia's Eastern Shore, p. 450) It is not proved that Jacob was the son of Daniel. Witnesses to his will were Richard Sturgis and Daniel Sturgis. Jacob purchased 230 acres at N83 from 1737. He left 100 acres to his son, Jacob, and 130 acres to his son, William. (Ralph T. Whitelaw, Virginia's Eastern Shore, p. 450)

?Jacob Sturgis and Adah Brickhouse had the following children:

32. **Richard³ Sturgis** (Richard², John¹) was born after 1680. Richard died 1744 in Accomack Co., VA. He married **Ann** (N). Richard received land in 1721 from his uncle, Daniel Sturgis, at A118 in Accomack County. Richard and his wife, Ann, sold the land in 1725 to John Bagwell. (Ralph T. Whitelaw, Virginia's Eastern Shore, p. 1134) Richard left a will dated April 30, 1744, probated May 30, 1744, in which he named his children and a grand daughter, Betty Sturgis, daughter of John Sturgis, dec'd. (Stratton Nottingham, Wills & Administrations of Accomack Co., VA, p. 142)

Thomas was under age in 1744. He received 50 acres of land at "Widows Lott" from his mother, Eleanor. 1783 Tax List shows him with

"Chance" 1M, 1F.

On November 1, 1783, Thomas gave his daughter, Sarah, and husband John Patrick, 50 acres of "Chance" and "Wildcat." (Liber K, f.581) Entries in Liber K shows several deeds by Thomas to: John Selby 48A Chance; Outten Sturgis 43A Chance; John Sturgis 60A Chance; Richard Sturgis 17A Chance. (Liber K folios 99, 161, 255, 256, 283 researched by Gerald Collins)

Thomas Sturgis and Sarah Outten had the following children:

Richard⁵ Sturgis. Richard died after 1780. Richard served in the Revolution as a Private, Worcester Militia, Snow Hill Battalion, Capt. Samuel Smyley's Company; 1777 listed as Richard Sturgiss. Private, Worcester Militia, Wicomico Battalion, Capt. William Handy's Company, 8th Class, July 15, 1780; Private, Maryland Troops, Worcester Co., draughted May 1, 1781. Took the Oath of Allegiance in Worcester Co. in 1778 before the Hon. John Selby (Henry C. Peden, Jr., Revolutionary Patriots of Worcester & Somerset Counties, p. 287)

On March 31, 1780, Richard's father, Thomas, deeded his 17 acres of "Chance." (Liber K, f.282-3 researched by Gerald Collins) He is not cited on the 1783 Tax List or in the 1790 census.

- 85 ii. John Sturgis. The 1783 Tax List shows John with "Chance," 1M, 2F. John of Thomas took the Oath of Allegiance in Worcester County in 1778 before the Honorable Joshua Townsend. (Henry C. Peden, Revolutionary Patriots of Worcester & Somerset Cos.)
- 86 iii. Outten Sturgis.
 - 87 iv. Sarah Sturgis. She married John Patrick.
 - v. William Sturgis. William died 1773. William died intestate.

40. **Richard⁴ Sturgis (II)** (Richard³, John², John¹) was born after 1724. Richard died before 1773. Mother, Elinor, deeded him 50 acres of "Widow's Lott." He patented "Sturgis' Choice" for 34 acres in 1760. The debt book for 1774 shows 34 acres of "Sturgis's Choice," and Richard was probably dead by this time.

His wife may have been Eleanor, who paid tax on "Widows Lott" in 1774.

41. **Stephen⁴ Sturgis** (Richard³, John², John¹) was born after 1724. Stephen died 1798 in Worcester Co., MD. He married **Elizabeth Ball**. Elizabeth died 1799 in Worcester Co., MD. Stephen was under age in 1744. The 1783 Tax List shows him with "Littleworth" 4M, 4F

He served as a Private, Worcester Militia, Snow Hill Battalion, Capt. John Parramore's Company, 1777. He took the Oath of Allegiance in Worcester County in 1788 before the Hon. Joshua Townsend. (Henry C. Peden, Revolutionary Patriots of Worcester & Somerset Cos.) Will dated August 6, 1798, probate October 12, 1798 named wife Elizabeth and left her plantation; son Stephen, plantation after wife's death; son Shadrack 50A "Worse Than Nothing;" granddaughter Sally Sturgis Hosier; children Peter Sturgis, Mary Tarr, Easther Hudson; Daniel Jones and Jessee Bennitt to divide estate; witnesses: John Houston, Nancy Bennitt and Jessee Bennitt. (Ruth T. Dryden, Worcester Will Book JWB, f.376.

Stephen Sturgis and Elizabeth Ball had the following children:

42. Comfort⁴ Sturgis (Richard³, John², John¹) was born about 1730. Comfort died about June 9, 1801 in

Worcester Co., MD.

She married three times. She married **Joshua Jones** about 1751. Joshua died 1773 in Worcester Co., MD. Joshua Jones made his will 1 April 1773, devising to wife Comfort all land Spittle Field during her lifetime and at her death to son John Jones, also to wife negroes Till, Sam and Stephen and all moveables during her lifetime except my riding horse; son Thomas Jones tract purchased from Hammon Runnals and my riding horse; to five children: Thomas, John, Mary, James and Rebecca Jones all moveable estate at the death of wife (15:34).

She married **Elijah Laws** before 1778. Elijah was born about 1723. Elijah was the son of William Laws. He married **Daughter Sturgis** before 1741. Elijah died 1778 in Worcester Co., MD. On the 1739 tax list for Bogerternorton Hundred of Somerset County, Elijah Laws was in the household of Joshua Sturgis, who was next to Rev. Thos Fletcher, who was rector of All Hallows Parish at that time. On 16 June 1741 Joshua Sturgis, Gent. for love and affection to my loving son...Elijah Laws, land Wicksnough (Wickenough, Wickeness) later in the deed it mentions my "Son in Law" [step-son?], Elijah Laws (MF:227).

Elijah is given 100 acres of "Wickedness Neck" as "son-in-law" by Joshua Sturgis in 1741. He purchased "Hog Quarter" in 1776 from John Jones. (Ruth T. Dryden, Worcester Land Records) His will was dated October 17, 1813, probated January 4, 1814. He named sons John, Elijah, James and Joshua and daughter, Patty. He left his son, James 146 acres in the forest of "Addition to Hog Quarter." Witnesses were William Townsend, Peter Townsend and Peter Evans. (Ruth T. Dryden, Worcester Will Book MH, f.27)

She married John Elmore before 1778. John died 1778 in Worcester Co., MD. She was under age in 1744.

Joshua Jones' will 1 April 1773, devised to wife Comfort all land Spittle Field during her lifetime and at her death to son John Jones, also to wife negroes Till, Sam and Stephen and all moveables during her lifetime except my riding horse; son Thomas Jones tract purchased from Hammon Runnals and my riding horse; to five children: Thomas, John, Mary, James and Rebecca Jones all moveable estate at the death of wife (15:34).

On 30 September 1800, Comfort Laws, late Comfort Elmore, with Thomas Jones and Peter Parker her sureties, was bound as administrator of the estate of John Elmore, dec'd (Worc JBR6:132).

Comfort Laws made her will 28 April 1801, devising to daughter Mary Parker one negro girl Diner; to grandson James Parker, son of Peter Parker negro boy Isaac; to grandson Joshua Jones negro boy Peter; to son James Jones negro boy David; to son John Jones youngest negro boy; to granddaughter Comfort Parker negro girl Harth; to granddaughter Elizabeth Walton Parker bed and furniture; son in law Peter Parker, executor; witnesses Isaac Hill, Elijah Brittingham (Worc JBR1:224).

Comfort Sturgis and Joshua Jones had the following children:

He bought land as Joshua of Richard in 1788. He is the Joshua of Richard cited in the will of Capt. Joshua Sturgis in 1773. Probably the Joshua Sturgis, Revolutionary Patriot. 1783 Tax List shows him with "Chance," and "Littleworth" 2M, 5F at Mattapony Hundred. Information from a family Bible or prayer book is on file at the Maryland Historical Society.

In 1768 John Milbourn sold to John Sturgis 33 acres "Offall Swamp" (Dryden, Worcester Land Records). In 1780 Tabitha Sturgis and Levin Sturgis sold 10 acres "Hog Quarter" to Joshua Duer. (Dryden, Worcester Land Records)

His will named wife Tabitha, son Levin and daughters Mary Henmon, Martha Sturgis, Sophia Allen and Sarah Sturgis. Estate inventory September 1, 1769 showed next of kin as Levin and Thomas Sturgis. Testamentary Proceedings July 20, 1769: John Sturgis his will and testamentary bond by Tabitha Sturgis, his executor and Zadock Selby and John Sturgis son of Daniel in the sum of 250 Sterling.

Mary was the daughter of Matthew Purnell and Martha McClemmy. Research of Dr. George Bishop indicates that Mary was the wife of John Sturgis. His wife at the time of his death was called Molly and she was most probably a second wife and mother of his three youngest children. Proof for this marriage is not known.

He married (N). John was living in Accomack in 1763. He bought land from Daniel Sturgis, son of John of Worcester, in 1767. 1783 Tax List shows him with "Rochester," "Double Purchase" and "Sturgis' Chance," 2M, 3F. 1790 census: 1M-16, 1M16+, 3F. John's first wife is unknown. It is thought that his second wife was Molly Purnell, daughter of Matthew & Martha McClemmy Purnell.

He is most probably the Joshua Sturgis Sr. living in Wicomico Hundred, Worcester, in 1783. Also probably the Joshua Sr. who was a Revolutionary Patriot. He bought "Safeguard" from David Cathell as Joshua Sturgis of John in 1774. In 1783 he is shown with tracts "Addition" in Wicomico Hundred, Somerset, "Safeguard," and "Manor Land." 3M, 5F.

A Joshua Sturgis, Jr. is shown as witness to the will of George Parker in 1767, when Parker leaves "Wickeness" to his son, John. Elijah and Elijah Laws, Jr. are also witnesses to this will. It is not known if this is Joshua Sturgis, Jr. son of Joshua or perhaps a Joshua Jr. son of Captain Joshua Sturgis who predeceased his father.

He is no doubt the Daniel Sturgis paying tax on "Double Purchase" in 1768 and 1769. (descendants researched by Gerald Collins)

Daniel Sturgis and Jane Bratton had the following children:

- Laban⁵ Sturgis was born about 1753. Laban died January, 1796 in Poquoson, VA. He may be the same Laban as shown on the 1782 Tax List in Delaware. He was of age in 1774.

Her mother's will calls her Martha Sturgis; the administration of her sister's estate calls her wife of Outten Sturgis in 1752.

He married **Sarah Cord** after 1792. Sarah was born July 10, 1744. Sarah was the daughter of William Cord and Rachel (N). She married **Joshua Atkinson** January 9, 1766. She married **James Townsend** in Worcester Co., MD, July 6,1774. Sarah died May 19, 1816 in Worcester Co., MD. Sarah Atkinson Townsend was twice widowed and was probably the daughter of William Cord. She wrote her will October 7, 1807 and named six children by her previous marriages to Joshua Atkinson and James Townsend. (Henry C. Peden, Jr., Revolutionary Patriots of Worcester & Somerset Counties, Willow Bend Books, Westminster, MD, 1999; Floyd C. Otter, Ash Tree Echo, Jan. 1981, Vol. XVI, p.37, Fresno Genealogical Society)

He made a will in Worcester Co., MD, September 18, 1795. Outten's will was probated in Worcester Co., MD, October 25, 1796. Outten served in the Lower House of the Maryland Legislature from Worcester County 1778-1779; Committee of Observation 1776; Commissioner of the Tax 1777-1778; Judge of the Court of Appeals under the Act to Procure Troops 1778; County Court Justice 1787-1795. He took the Oath of Allegiance in Worcester County in 1778 before the Hon. Nehemiah Holland and rendered patriotic service by supplying corn for the use of the military on March 8, 1780, and July 10, 1780. (Henry C. Peden, Jr., Revolutionary Patriots of Worcester & Somerset Counties, Willow Bend Books, Westminster, MD, 1999)

In 1755, Outten bought part of "Pharsalia" called "Buck Neck"; In 1795, he left 300 acres to daughters Polly, Martha and Esther. (Ruth T. Dryden, Worcester Land Records, p. 472). In 1768, George & Martha Stewart of Accomack sold 295 acres "Kings Neck" to Martha Sturgis. In 1790, Outten and Martha sold the 295 acres fo Joshua. In 1796, George Turner sold 39 acres to Joshua of Outten. The 1783 tax list shows Outten with "Pharsalia," and "King Harry's Neck," 2 males, five females.

He is called son-in-law by Martha Selby in her 1780 will. His wife at the time of his death was Sarah. Outten and Sarah are named in a claim of Atkinsons heirs against James Townsend's estate and that Outten and Sarah are guardians to William Cord Townsend. (David V. Heise, Worcester Co. MD Orphans Court Proceedings Vol I) he mentions a grave for his wife now deceased. He named granddaughter Elizabeth Custis Sturgis, grandson William Custis and granddaughter Polly Custis, and sons-in-law Benjamin Gunby, James Selby and Benjamin Aydelotte as executors. He names his daughters Polly Selby, Martha Aydelotte and Esther Gunby. Outten added a codicil naming Esther, daughter of Abraham Outten Sturgis.

Samuel Smyley's Company, August 30, 1777 and is shown as 2nd Lieutenant, Worcester Militia Wicomico Battalion, Capt. Samuel Smyley's Company July 15, 1780. He took the Oath of Allegiance in Worcester County in 1778 before the Honorable Joshua Townsend. (Henry C. Peden, Revolutionary Patriots of Worcester & Somerset Counties)

John received "Robinsons Inheritance" from his father in 1749; John and wife Sarah sold 250 acres in 1769 to Parker Selby of Parker. John left "Friends Assistance" to his son, James, and grandson Henry Sturgis of John. He purchased 26 acres of "Conveniency" from Littleton Dennis in 1773 but had 150 acres in the 1783 tax. John purchased 228 1/2 acres of "The Hammer" from Moses Nelson in 1809 and left to his son James 28 1/2 acres. (Ruth T. Dryden, Worcester Land Records) 1783 Tax List: "Conveniency" 4M, 4F.

He named grandsons, Henry, Handy Mills and John O. Sturgis of son John O. In 1792, Levin and wife, Betty, deeded 31 acres "Goose" back to Joshua Duer. 1792 he also sold to Joshua Duer 22.25 acres "Offall Swamp," "Timber Quarter," and part "Hog Quarter." (Dryden, Worcester Land Records)

1800 census, Worcester Co. MD: 01210-01010 as Levin Sturgis. There is another Levin Sturgis 20010-00010, and a Levin Sturgis, Jr. 00010-10010. 1810 Census, Worcester Co. MD: 00111-00101. 1820 census Worcester Co. MD as Levin Sturgis, Sr.

The 1783 Tax List shows Richard with "Widow's Lott," "Hardship Branch," and "Sturgis Choice", 3M, 5F

In 1808, Richard and wife Leah sold "Sturgis' Choice" to George Nelson.

1810 census is difficult to read, but the entry appears to read Richard Sturgis SENR 1M45+, 1F-10, 1F26-45

From census records, Richard may have had other children living in his household, along with his step-daughter, Nancy Gunn.

There is a Richard Sturgis Sr. in the 1820 census of Worcester County (p. 181) and there is Levi of Richard. No will or administration for a Richard Sturgis has been located. Bishop indicates that this Zipporah is not the sister of John Bishop and daughter of Benjamin Bishop d. 1767. Zadock received "Rochester" from his father. 1783 Tax List - no land, 1M, 0F. 1790 census: 2M-16, 2M16+, 4F. 1800 census: 3M-10, 2M10-16, 1M16-26, 1M26-45, 1F-10, 2F10-16, 1F26-45. 1810 census: 2M10-16, 1M45+, 2F16-26, 1F45+. 1830 census: 1M40-50, 1M70-80, 2F40-50.

Research of Vern Skinner from Worcester Estate Dockets: Zadock Sturgis and Jacob Teague were sureties for estate of Esther Pettit in 1801, administered by John Bishop. Zadock Sturgis and Jacob Teague were sureties for estate of John Wright in 1800, administered by Atlanta Wright and John Bishop. Zadock Sturgis and Jacob Teague were sureties for estate of Hannah Riggen in 1795 with John Bishop, administrator. Zadock rejected administration of the estate of Esther Sturgis in 1806.

Zadock served as Private, Worcester Militia, Sinepuxent Battalion, Capt. William Purnell's Co., 8th Class, 1779/1780. He rendered patriotic service by collecting cattle for the use of the military on October 25, 1781. (Henry C. Peden, Revolutionary Patriots of Worcester & Somerset Cos.)

Zadock made his will May 27, 1831, probate August 21, 1835. He named children: Mary, Elizabeth, John and Thomas and left real estate to two daughters. A codicil dated May 17, 1835 gave his daughters authority to sell 100 acres purchased of Samuel Ennis called "Wright Farm." Witnesses to will: David K. Hopkins, Thomas R. Rownd and John Sturgis Jr.; witness to codicil: Jacob Wonnell. (Ruth T. Dryden, Worcester Co. MD Will Book LPS, f.50)

After her death, Tabitha's brother-in-law apprenticed the two boys and sold 'Middlemore.' 1807 Orphan's Court Proceedings: James Sturgis was placed in the poor house to learn the trade of a tailor.

Joshua Guthery's will dated 1787 and probated October 6, 1788 named his daughter, Nancy Williams, and his grandson, John Williams (wills at Ocean City Lifesaving Museum transcribed by Susanne B. Hurley). Orphans court records show young John Williams, Jr. as age 5 on 25 June last, and appointed guardian Nancy Williams; sureties were Joshua Guthery and Zadock Selby, August 15, 1788. Then on August 2, 1797, John Williams of John, now over 14, selects Levi Sturgis as his guardian; sureties: Richard Sturgis & Thomas Jones. (David V. Heise, Worcester Co. MD Orphans Court Proceedings, Vol. I) It would appear that young John Williams' mother, Nancy Guthery Williams, is deceased by 1797 and he selects his sister's husband, Levi Sturgis, as his guardian. Levi is shown born between 1755-1774 in 1800 census. In 1800, he is enumerated on the same page as his father, Richard, and his name appears "Levin:" 2M-10, 1M26-45, 1F26-45. In 1810: 2M10-16, 2M16-26, 1M26-45, 1F-10, 1F10-16, 1F16-26, 1F45+. 1810 census: 2M10-16, 2M16-26, 1M26-45, 1F-10, 1F10-16, 1F16-26, 1F26-45. He is shown as living on land of John Richardson, heir of Robert M. Richardson (MH15:291) In 1820 he is shown as Levi of Richard and is enumerated one line away from Zadock Sturgis, Esq., next to Parker Selby, then William Selby of Zadock: 2M16-26, 1M45+, 1F16-18, 1F16-26, 1F26-45. Levi does not appear in the 1830 census for Worcester or Somerset.

At court on August 2, 1797, Levi Sturgis was chosen guardian by John Williams, orphan of John. Sureties were Richard Sturgis and Thomas Jones. (David V. Heise, Worcester County, MD Orphans Court Proceedings, Vol. I) John Williams is over age 14 and it would appear that his mother, Nancy Williams, is now deceased and that young John Williams, Jr. selected his sister's husband as his guardian. In 1801, as guardian to John Williams, he was discharged from passing accounts. (JBR3:191). In 1809, Levi Jones, of James, age 17, was bound to Levi Sturgis to learn trade of farmer; sureties: James Sturgis, John Sturgis (MH7:552).

In 1803, Levi purchased 7 1/2 acres of The Hammer from Hugh Nelson. He is shown in the deed as Levi of Richard. In the 1820 census, he is also shown as Levi of Richard. The land at The Hammer would have put Levi in close proximity to cousin, James Sturgis d. 1828, who also owned land that was part of this tract. Levi's granddaughter would marry James' son, John Raymond Sturgis, who inherited his father's lands at The Hammer.

Mr. Sturgis was absorbed in Hillsboro business pursuits, and gave little attention to political matters, but did serve as treasurer for the City of Hillsboro. He accumulated a considerable fortune, and built a spacious home in the 400 block of Corsicana Street. He was married to Julia Vineyard of Louisana, whose family came to Hill County in 1873.

337 x. William White Sturgis was born in Worcester Co., MD June 8, 1851. William died after 1892 in Vanwert Co., OH. He married Ellen Howard on December 18, 1878, Hill Co., TX. She was born about 1861 in Louisiana. They are enumerated next to his brother, George, in 1880.

249. **Zadock**⁷ **Sturgis** (John⁶, Zadock⁵, John⁴, John³, John², John¹) was born in Worcester Co., MD about 1822. Zadock died 1886. He married **Sarah Hanline** in Philadelphia, PA, 1853. Sarah was born 1833. Sarah was the daughter of Alfred Hanline. Sarah died 1865. Sarah's father left money to his granddaughter, Lydia Holby. Sarah Hanline obituary, Philadelphia Public Ledger August 23, 1865. Zadock was alive in 1865 and named in his father's will and in the distribution of the estate. He does not appear in the 1850 Worcester census.

He may be the Zadock Sturgis who was in Philadelphia, PA in 1853. The 1854 Philadelphia directory shows Zadock, clerk, 169 Market St., home is 156 Market St. He appears in the 1880 city directory with an Edward Sturgis, butcher, at the same address. The 1885 directory lists a Zachariah Sturgis at the address.

Zadock of Philadelphia had a son, John D. Sturgis b. 1857, Philadelphia, PA. John D. Sturgis had two children: Maggie and Zadock (birth certificate spelled Ezeadock) (notes of Kay Davis)

Zadock Sturgis and Sarah Hanline had the following children:

- 338 i. Lydia⁸ Sturgis was born 1854. She married an unknown person. Lydia married (N) Holby and had a son, Albert H. Holby. Zadock Sturgis' sister, Mary named Lydia's son, Albert Holby, in her 1915 will. (Worcester Wills, EPD#10:352, research of Vern Skinner)

She married Augustus Johnson in Coventry Parish, Somerset Co., MD, January 19, 1848. Augustus was the son of Isaiah Johnson. Augustus died March 21, 1862 in Somerset Co., MD. Of Accomack County, VA. (Leslie Powell Dryden, Dryden Family and Descendants; Linda Harrison) After her husband's death and before 1870, Elizabeth moved with her children to Baltimore, MD, where she supported herself as a seamstress and her son, Francis, worked as a plasterer. (Linda Harrison)

Elizabeth Sturgis and Augustus Johnson had the following children:

- i. Littleton "Francis"⁹ Johnson was born in Somerset Co., MD February, 1849.
- ii. Alice Olivia Johnson was born in Somerset Co., MD May 15, 1853. Alice died March 9, 1887 in Baltimore, MD. She married George H. Harrison 1873. George was the son of Nicholas S. Harrison and Elizabeth Greenfield. The 1880 census shows Sarah Sturgis, aunt, living in his household, along with three of her daughters. Alice died of cholera the day after her daughter, Alice, was born. Her sons were sent to a boys' school and baby Alice was taken to be raised by "her mother's sister, Louise Foster." No record is found of Alice having a sister named "Louise" however, Zelenro and George J. Foster were keeping Alice in 1900. This is probably Zelenro Sturgis, Alice's first cousin. (research of Linda Harrison)

320. **Sarah Ann Priscilla⁸ Sturgis** (Littleton⁷, Levi⁶, Richard⁵, Richard⁴, Richard³, John², John¹) birth date unknown. She married **John Raymond Sturgis** in Coventry Parish, March 3, 1847. John was born in Worcester Co., MD about 1822. John was the son of James Sturgis and Sarah C.(wife of James Sturgis). His father left his land at "Friends Assistance," and "The Hammer" in his 1828 will. (Ruth T. Dryden, Worcester Land Records) Also owning a tract at "The Hammer" was Levi Sturgis, a cousin, whose granddaughter married John Raymond.

John was killed in a steam mill accident before 1880. (research of Linda Harrison) Sarah is shown in the household of George H. Harrison in 1880 and called "aunt." Annie, Louise and Mary are with her. (research of Linda Harrison)

John Raymond Sturgis and Sarah Ann Priscilla Sturgis had the following children:

- i. Sally Elizabeth Catherine⁷ Sturgis was born February 21, 1848.
- 282 ii. Ann Priscilla Sturgis was born January 9, 1851. She is shown as Annie P., age 30, in the 1880 census, living in the household of George Harrison.

- 284 iv. Zelenro "Louise" Bell Sturgis was born April 12, 1859. She married George J. Foster. George died 1935. The 1900 census shows George and Zelenra Foster caring for the children of Alice Johnson & George Harrison after Alice's death. The relationship is shown as "cousins." (Alice and Zelenra were first cousins, their mothers being sisters) A George "H." Foster b. 1868 was a boarder in the home of Alice Harrison; the same Alice who lived with Zelenra & George as a child. Alice buried George

Foster in the Harrison family plot. She evidently went by the name "Louise" and is shown in the 1880 census with her mother and sisters living in the household of George Harrison. (research of Linda Harrison)

285 v. Marietta "Mary" Sturgis was born August 7, 1861. She married twice. She married Unknown Anderson. She married Nicholas "Wilbur" Harrison. Nicholas was the son of Nicholas S. Harrison and Elizabeth Greenfield. He married May Roberts. She is shown as Mary, age 18, living in the household of George Harrison in 1880. That she is the Marietta who married Wilbur Harrison is speculative, but Wilbur's brother did marry her sister.

323. **Priscilla E.**⁸ Sturgis (Littleton⁷, Levi⁶, Richard⁵, Richard⁴, Richard³, John², John¹) was born in Somerset Co., MD about 1837. She married **James D. Moore** in Somerset Co., MD, April 20, 1856. His first wife was Eleanor Mc N. by whom he had two children. (Leslie Powell Dryden, Dryden Family and Descendants, Book I, 1992, p. 219)

Priscilla E. Sturgis and James D. Moore had the following children:

324. Littleton Henry⁸ Sturgis (Littleton⁷, Levi⁶, Richard⁵, Richard⁴, Richard³, John², John¹) was born in Coventry Parish, Somerset Co., MD May 17, 1839. Littleton died May 2, 1906 in Cape Charles, VA. He married Alexine "Ella Roberta" B. Marshall January 5, 1867. Alexine was born in Snow Hill, MD August 15, 1843. Alexine was the daughter of Robert Henry Marshall and Elizabeth Birckhead. She married C. F. Foster in Somerset Co., MD, May 7, 1860. Alexine died February 7, 1919 in Roanoke, VA. The family Bible belonging to her brother spells her name with "i" and it has been transcribed as Alexene and also written this way in an 1894 diary. But she went by the name Ella for all her official records. It is thought the middle initial, "B" is for Birckhead, her mother's maiden name.

The family Bible of her brother also showed her date and place of birth and written in pencil after the entry "Mrs. Littleton H. Sturgis"

In her 1894 diary, Ida Lankford noted "Alexene came." It would appear it was a day visit, as Ida did not mention that her guest stayed the night; Ida was Alexene's cousin and lived at Princess Anne.

As Ella B. Sturgis, she is living at Elliott Road, Franktown, Northampton Co. VA, in 1910, with her daughter's family, Elizabeth & Frank Rolley. She is shown as mother-in-law, age 67, a widow who had 7 children and all 7 survived.

Ella's death certificate gave her name as Ella Roberta Sturgis and shows she was buried on February 9, 1919 at Fairview Cemetery, Roanoke, VA. She was living with her daughter, Ella Rolly, on Day Street, Roanoke, Virginia. A letter from Ella Sturgis dated 1919 indicates she may have had a stroke sometime shortly before her death. She signed her letters "Mama Ella" and "Mama Sturgis." Littleton appears in the 1850 and 1860 census in his parents' household, Dublin District, Somerset Co. MD. His children's ages taken from 1880 census. Littleton's date of death was recorded on a funeral card. (Leslie Powell Dryden, Dryden Family and Descendants, Book I, 1992, p. 219)

Littleton was one of the first businessmen in Cape Charles, VA. He was proprietor of a small 5-room hotel located on railroad property in 1883 and later the Arlington Hotel, which opened in Cape Charles in 1886.

Littleton Henry Sturgis and Alexine "Ella Roberta" B. Marshall had the following children:

- Minnie "Belle"⁹ Sturgis was born in Worcester Co., MD about 1868. She married twice. She married John Edwin Mills. John was born about 1854. She married Unknown Holman.
- ii. Susan Alice Sturgis was born April, 1870.
- iii. Elizabeth Augusta "Gussie" Sturgis was born in VA about 1872. She married Frank J. Rolley about
 1891. Frank was born in VA about 1868. Elizabeth A. is found in the 1910 census at Eliott Road,

Franktown, Northampton Co., VA, age 38, married 19 years, having had 5 children and 3 surviving. Her husband is Frank J. Rolley, 42, born VA. He is a farmer on a truck farm, owning his own farm. They moved to Roanoke, VA before 1919 and are shown there in 1920.

- 354 iv. Littleton Marshall Sturgis was born about 1874. He was living in Queens, NY, 4546 40th Street, in 1930, age 54, occupation, investment stock broker, married 19 years. Living with him is his brother, Carroll.
- v. Ida E. Sturgis was born about 1876. She married Larry McCabe. Ida's stage name was "Jaque."
- vi. Carroll Chase Sturgis was born in Cape Charles, VA April 17, 1882. Carroll died January 24, 1942 in Chester Co., PA. He married twice. He married Mary "Mae" P.(wife of Carroll Sturgis). He married Helen Fletcher Cooper about 1903. Helen was born in Bethlehem, MD about 1892. Helen died February 4, 1959 in Washington, DC. HELEN was the daughter of FLETCHER COOPER and ANNA OZMON. 1920 census shows him living in Baltimore, occupation as chef. Carroll and Helen divorced about 1930. Carroll owned a restaurant in Pennsylvania. He is buried at Mt. Moriah Cemetery, Philadelphia, PA. (death certificate) The telegram announcing Carroll's death was in possession of his daughter. Another death registration letter was sent to Mrs. F. J. Schmoele in Norfolk, VA. (It is unknown, but believed that one of Carroll's sisters married Schmoele.) (research of Frank Courtney)

He is living with his brother, Littleton in 1930, 4546 40th Street, Queens, NY, age 45, occupation as investment stock broker. The census shows he was married for 27 years.

328. Littleton J. (James)⁸ Sturgis (James W.(Wilson) L.(Littleton)⁷, Littleton⁶, Zadock⁵, John⁴, John³, John², John¹) was born in Worcester Co., MD 1830. Littleton died about 1883 in Hillsboro, TX. He married Sarah Margaret Ennis in Worcester Co., MD, December 18, 1854. Sarah was born August 31, 1824. Sarah was the daughter of Stephen Ennis and Martha Horsey. She married John Dale Powell in Worcester Co., MD, November 2, 1842. Sarah died after 1883. She was the widow "Powell" when she married Littleton Sturgis. All birth dates for Littleton's children taken from St. Martins Baptism records. (research of Linda Harrison) The 1850 census shows his occupation as merchant. He was in Worcester for 1860 census and at Hillsboro, Hill Co., TX by 1870.

Mary K. Sturgis, age 21 (b.c. 1849) is in the 1870 household of Littleton Sturgis, is step-daughter, Mary K. Powell.

Littleton J. (James) Sturgis and Sarah Margaret Ennis had the following children:

Children of Edwin and Rosalie: Eddie b.c. 1865; James b.c. 1867; Littleton b.c. 1869; Rowena b.c. 1871; Sallie b.c. 1879.

The Waco County Morning News, Tuesday, April 30, 1895: Hon. E. A. Sturgis died yesterday at his residence, 4th & Clay. His daughter Sallie, died early last year, and two grandchildren fell victims to the plague. Born in Worcester Co., MD, November 29, 1832. He merchandised. To Memphis; to Arkansas. To Waco in 1860. Enlisted in Capt.

Richard Coke's company. He leaves an estate valued at about \$300,000. Mayor of Waco, 4 terms. Funeral today from the residence, Dr. R. C. Burleson and Dr. S. A. King officiating. Burial at Oakwood cemetery. A member of Pat Cleburne Camp. (Gerald Collins)

An Edward Sturgis appears in the Philadelphia, PA city directory 1880-1894 as a butcher with Farrell & Sturgis. His address is the same as, Zadock Sturgis. The 1885 directory also shows a Zachariah Sturgis at the same address. (research of Kay Davis)

Edwin Anson Sturgis had the following child:

i. Edward Anson⁹ Sturgis (Jr.) was born April 11, 1865. Edward died March 18, 1928 in Jefferson Co., KY. He married Katherine McLendon in McLennan Co., TX. Katherine married 2nd Joseph Harrison Shelton and she died October 17, 1921 at Waco, McLennan Co., TX.
